

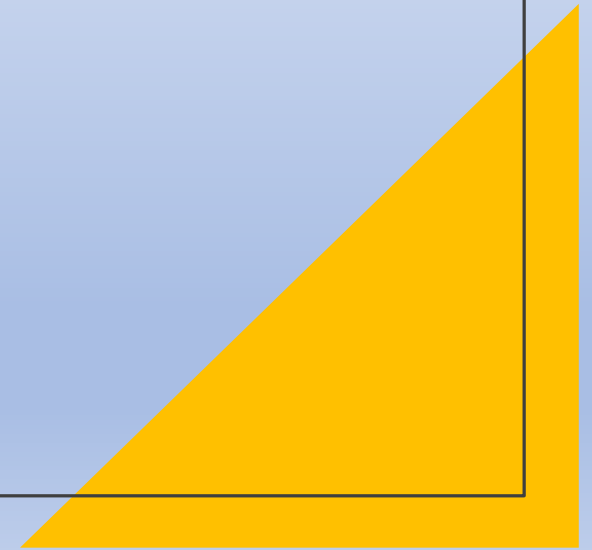

CGA Well Monitoring

Brittany recently conducted the semi-annual well monitoring for CGA with Confluence.

We monitored 23 wells in total with 8 sampled for water quality.

Anticipate payment approval in November

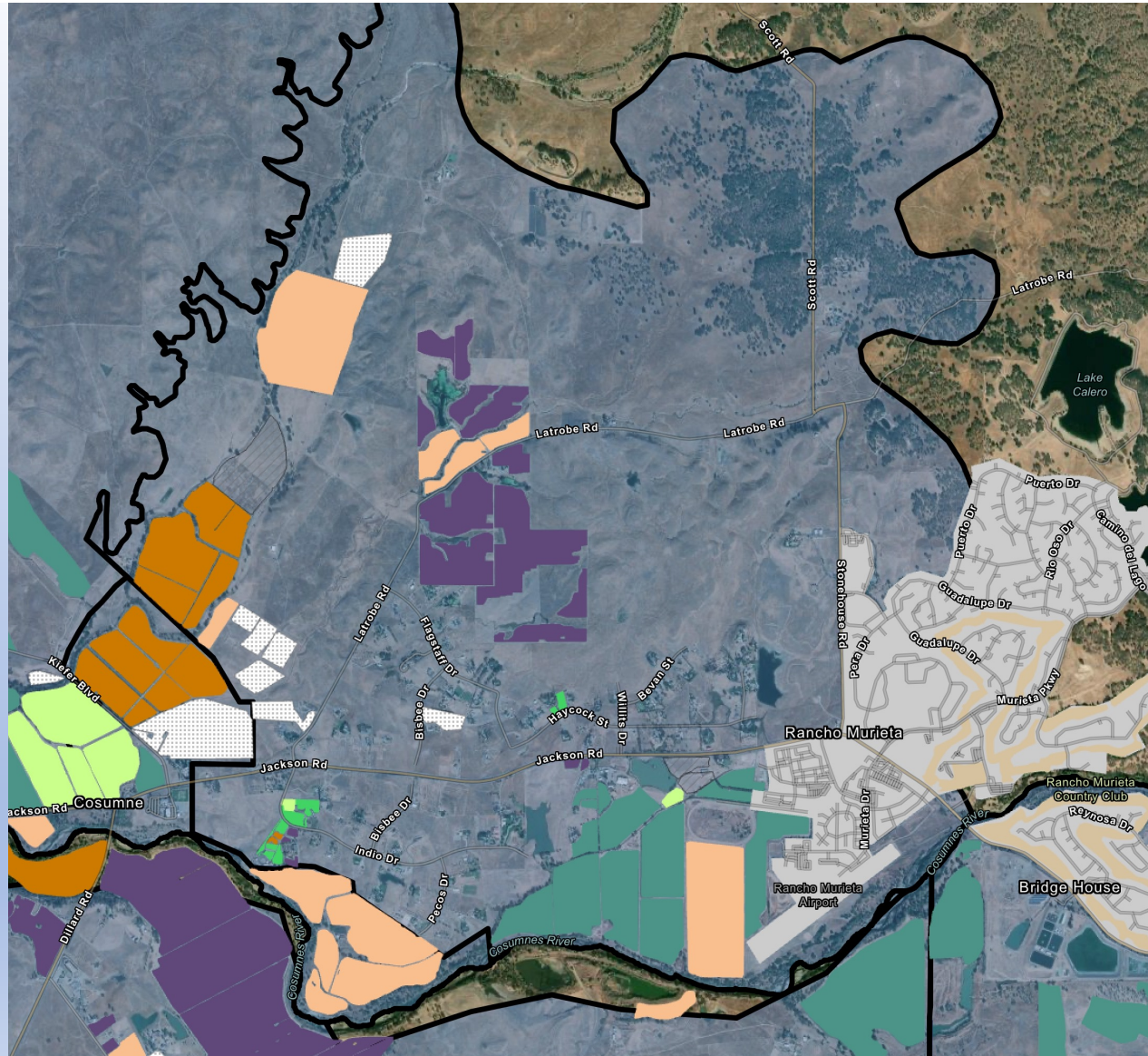
FY 23-24: Same as previous year (\$8,325)
